**Separate fees:** All 50 states have a separate filing fee due up front. For example, the Nevada State expedite fee is \$200. If you incorporate in Nevada, you may be required to have a state business license; the Nevada State Business License is \$200. The initial list of officers is \$125. This list and state business license (unless the entity is exempt) is due by the end of the month after your filed date. There is only one form and both fees (total of \$325) are due at that time. A local Nevada business license is separate and varies from situation to situation.

Each state may or may not have its own fee for an initial list, annual report, franchise tax fee that varies from state to state. It is recommended that you check with your local tax professional after the entity is filed for compliance in your state, local and city level. If the entity is required to foreign (qualify) register in another state, that fee is separate and varies state by state.
